Without limiting any of the foregoing, in no circumstances will a Participant or the Promoter have any liability to the other for any loss or damage suffered which is indirect or consequential in nature, including without limitation any loss of profit, loss of reputation, loss of goodwill, or loss of business opportunity.
17. The Promoter and its associated agencies, affiliates and companies will not be liable for any damage in transit to or delay in transit of eligible Product/s.
18. The Promoter may in its absolute discretion not accept a particular entry, may disqualify an entry, or cancel the entire Promotion at any time without giving reasons and without liability to any Participants, subject to any written directions from a regulatory authority. Without limiting this Clause, the Promoter reserves the right to verify eligible product claims and Participants and to disqualify any Participant who submits an entry or eligible Product/s claim that is misleading or not in accordance with these Terms of Entry or who manipulates or tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage during or following the conclusion of the Promotion does not constitute a waiver of those rights.
